

TERMS & CONDITIONS

1 Introduction

- 1.1 This 'Shop & Play to WIN' (Promotion) is conducted by Clarence Property Corporation Limited – North Shore Marketplace as the responsible entity of North Shore Townsville Property Trust (Promoter).
- 1.2 These terms and conditions apply to all entries into and/or prizes awarded under the Promotion.
- 1.3 The laws of Queensland apply to the conduct of the Promotion and the interpretation of these terms and conditions.
- 1.4 By submitting an online or physical entry into this Promotion, Entrants warrant that they have read, understood, and have accepted and agreed to be bound by these terms and conditions.

2 Duration

- 2.1 This Promotion runs from Thursday 24th November to Friday 23rd December 2022 concluding at 12:00 PM AEST.

3 Eligibility

4a Method of entry – Shop to WIN

4a.1.4 Retain a valid receipt as proof of purchase and to confirm the amount spent.
